### 1. SUBJECT

Global Grant #1743565 “Suicide prevention model and its application in the municipalities of Lithuania” in Anyksčiai District Municipality, Lithuania

### 2. PURPOSE

**6. ROTARY INTERNATIONAL DISTRICT 2305 SHALL:**

- A. Provide financial assistance
- B. Perform project management that can be done remotely
- C. Participate in service during site visits

**7. ANYKSCAI DISTRICT MUNICIPALITY SHALL:**

- A. Create local suicide prevention group in Anykscai district municipality, appoint team leader, issue proper authorization and ensure favorable conditions for its operations
- B. Together with the experts participating in the project, develop a plan for suicide prevention and ensure its implementation, taking into account the situation and the needs of the Anykscai district municipality
- C. Ensure the continuity of the project activities after end of the project term

**8. MODIFICATION**




Modifications within the scope of this document shall be made by mutual consent of the parties, by the issuance of a written modification, signed and dated by all parties, and approved by The Rotary Foundation prior to any changes being performed.
